

ADVERTISEMENT FOR BID

Town of New Chicago – 2021 Water Improvements Project

Sealed Bids for the construction of the 2021 Water Improvements Project will be received by the Town of New Chicago – Town Council, 122 Huber Blvd, Hobart, IN 46342 until Thursday, September 23rd, 2 PM Local Time, at which time the Bids received will be publicly opened and read at the Town Hall, 122 Huber Blvd, Hobart, IN 46342. The Project consists of installing new replacement water mains along North Lake Avenue and in the Nob Hill Subdivision by directional drilling and open cut methods.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis. Two (2) copies of the Sealed Bids bearing the project name as well as the name and address of the bidder shall be submitted to: Town of New Chicago, Town Hall, 122 Huber Blvd, Hobart, IN 46342.

Bidding documents will be available on August 25th, 2021 at 7 AM local time. Electronic contract documents can be obtained online from the Abonmarche website, found at <http://www.abonmarche.com/bids>. There is no fee for registration on the plan holder's list and download of electronic bidding documents. Hard copies are available from ABONMARCHE CONSULTANTS, INC., 17 N. Washington Street, Valparaiso, IN 46383. (219) 850-4624. The fee for obtaining a hard copy documents is Fifty Dollars (\$50.00). An additional Ten Dollars (\$10.00) will be charged for plans requiring shipping. General Specifications, description and conditions upon which the bid proposal is to be based are on file for examination at the office of the Engineer, Abonmarche Consultants, Inc. 17 N. Washington Street, Valparaiso, IN 46383.

A certified check, cashier's check or bid bond in an amount equal to five percent (5%) of the total amount of the bid will be required with each bid as security for the proper execution of the contract. A 100% Labor, Material, and Performance Bond will be required of successful bidder. Bidder shall submit Indiana State Form 96 and be certified to do work in the State of Indiana. Additional Bidding requirements are in the Instructions to bidders included in the Project Documents. This project will be funded with State Revolving Fund (SRF) loan Funds. The Contractor shall be required to meet the SRF requirements regarding wage rates.

A pre-bid meeting will be held at Town of New Chicago Town Hall for this project on September 3rd, 2021 at 10 AM Local Time.

No bid shall be withdrawn for a period of sixty (60) days after the scheduled opening without consent of the Owner. The Owner reserves the right to reject any and all bids, waive any informality in bidding or to accept the bid, consistent with law, which best serves the interest of the Owner.
